WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Shri Gauri Shankar Sanskrit Mahavidyalaya, Suganganj, Jaunpur, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting B.Ed Course of One year duration with an annual intake of 100 (One Hundred Only) students on 24.07.2006.

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 116th 2nd Sitting Meeting held on 07th to 08th May 2007 the committee decided to issue Conditional Letter of Recognition to the institution and accordingly conditional recognition order was issued vide NCTE letter no. F.NRC/NCTE/F-3/UP-2160/2007/7882-84 Dated 26.05.2007.
- 3. AND WHEREAS the applicant institution submitted representation to Northern Regional Committee, NCTE, Jaipur on 06.07.2007 and the matter was placed before NRC in its 141st Meeting held on 22nd to 24th May 2009 and the committee decided to refuse the recognition for B.ED Course of one year duration. Accordingly order was issued vide order no. F.NRC/NCTE/F73/UP-2160/141 MEETING/2009/8069-75 dated 14.08.2009. The above said institution, thereafter preferred an appeal dated 30.07.2009 to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, and accordingly remanded back the matter to NCTE NRC with the direction, to immediately issue the order of recognition to the institution, in its order no. **F.NO. 89-766/2009 -APPEAL dated 08.10.2009.**
- 5. AND WHEREAS the matter was again placed before the NRC NCTE in its $151^{\rm st}$ Meeting held on $20^{\rm th}$ to $21^{\rm st}$ October 2009 and the committee decided process the file as directed.
- 6. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Shri Gauri Shankar Sanskrit Mahavidyalaya, Suganganj, Jaunpur, U.P. for conducting B.Ed Course of Secondary (Level) of One year duration with an annual intake of 100 Students (One Hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to 3(1)/2008/NCTE (N&S) dated 01/10/2009:
 - I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the
 - II. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.
- 7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- 8. The institution shall comply $\mathbf{w}(\mathbf{r})$ the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
